ENROLLMENT REQUIREMENTS

Service requires students to be enrolled in at least 12 units between 7:30 a.m. – 3:30 p.m. Monday through Friday. Families from the community are also required to have a need for child care which is determined through the application process.

The following documentation is required:

- Proof of family gross income (before taxes)
- Employment verification or training verification
- · Identification/emergency information
- · Birth Certificate
- · Current immunization record
- · Pre-admission health examination
- Proof of address

CDC and FCCHEN each requires an individual application to be considered.
