LAMC-LACCD PROCESS

- X CalWORKs students who enroll at multiple LACCD campuses must enroll in each campuses CalWORKs office
- You will need to reach out to the LACCD Campus CalWORKs office and submit required documents (just as you did for LAMC)
 - X Be prepared to submit:
 - Intake packet the same intake for all LACCD campuses (request from LAMC CalWORKs staff)
 - LAMC's GN 6006 (request from LAMC CalWORKs staff)
 - GN 6390 (request from your GAIN worker see sample on next slide)
 - X Each campus has its own process and required documentation
